

Regulation

§1

General resolutions


- 1.1. The present Regulation is defining rules and obligations of The Nationwide Conference of Chemical Technology and Biotechnology KonTeCh's participants.
- 1.2. The Science Conference takes place at Wrocław University of Science and Technology on 9th and 10th June 2018 according to the schedule placed on Conference website: <http://www.kontech.pwr.edu.pl/>
- 1.3. Organizers of the event are following Scientific Circles working at Chemical Faculty of Wrocław University of Science and Technology: *Studenckie Koło Naukowe Technologii Chemicznej ChemiTech*, *Koło Naukowe Kiwon* and *Koło Naukowe Studentów Biotechnologii "Bio-Top"*. They are called further as *Organizer*.
- 1.4. Rules of this Regulation cover all Participants and are integral part of registration. Each Participant is obligated to abide Regulation and adhere to recommendations of Security Service and representatives of Organizer.

§2

The Conference

- 2.1 The aim of the event is promotion of students' scientific development, creation of forum to discussion, presentation of the scientific achievements and chemical, technological, biotechnological, industrial knowledge.
 - 2.1.1 Within The Nationwide Conference of Chemical Technology and Biotechnology KonTeCh takes place posters' sessions.
- 2.2 The detailed schedule of the Conference is published at website: <http://www.kontech.pwr.edu.pl/>
- 2.3 The Organizer reserves the right to dispose of Participants' list in order to correctly organize the Conference.
- 2.4 The Organizer reserves the right to cancel the Conference in case, when number of reported abstracts will be lower than 20, or other independent reasons. In this situation the Organizer will return the whole amount of the Conference Fee to Participants.
- 2.5 The Organizer reserves the right to make a changes in the Regulation. The information about the changes in the Regulation will be published at the Conference website in the day of their implementations.


- 2.6 The Conference is closed and it is not a massive event according to the Law from 23rd March 2009 about Safety of Massive Events (Dz.U. 2009 nr 62, poz. 504).

§3

Participation in conference

- 3.1 On the participation in the Conference decide the registration order. The registration of the Participants takes place from 9th April till 9th May 2018.
- 3.2 Students of 1st, 2nd or 3rd degree can actively participate in the Conference, if they would register in the impassable term given at the Conference website.
- 3.3 The Participant needs to register and pay the Conference Fee – 175 PLN, on-time, in order to participate in the Conference. The Conference Fee should be paid in the form of PayU transfer at the portal polibudka.pl (<http://polibudka.pl/>).
- 3.4 The cost of participation in the Conference, accommodation and transportation is covered by Participant. The Organizer ensures the access to catering during the event and organizes the banquet at 9th June 2018. The detailed information is published at Conference website.
- 3.5 The Participant is committed to:
- Pay the Conference Fee from 9th April till 14th May 2018 at the portal polibudka.pl. In the transfer title must be written "Opłata Rejestracyjna – *Surname and First Name*".
 - Delivery on time to the Organizer the poster abstract and picture with short note about yourself (achievements, publications, projects, etc.), till 15th May 2018. Scheme of the Abstract and Short Note is available on the Conference website.
 - Presentation of the poster of review or own scientific results. The editors standards:
 - Poster should have A0/A1 format.
 - Poster could not breach the copyrights, the legitimate and material interests of third party according to the Law from 4th February 1994 concerning copyright laws and associated rights (Dz. U. nr 24, poz 83 z późn. zm.) and should be not earlier presented.
- 3.6 Participants posters are collected in the day of the Conference in the registration point and will be hang in appropriate place.
- 3.7 The Organizer takes no responsibility for wrong or fake data in registration by the Participant of the Conference.
- 3.8** The registration to the Conference stands for acceptance of this Regulation, compliance of law and all agreements between the Organizer and Participant.

§4

Resignation

- 4.1 The Participant has the legal right to resign from the Conference. The Resignation of the Participant should be made in written form till 10th May 2018 and send on the e-mail address: kontech.konferencja@gmail.com
- 4.2 The Conference fee will be not returned in case of the resignation in later deadline than given in the point 4.1, or an absence of the Participant.
- 4.3 The Organizer grants permission to change the Participant, if deadlines given in the point 3.5 B will be kept.

§5

The Conference Fee

- 5.1 The cost of the Conference Fee is given at the Conference website.
- 5.2 The lack of the Conference Fee's settlement in the given by the Organizer deadline at the Conference website empowers the Organizer to cancel the participation application, without taking any responsibility for that action.

§6

The Safety

- 6.1 The Participant of the event is obliged to absolute subordination to commandation of Organizer or authorized persons.
- 6.2 The Participants are obliged to behave in the way, that they will not threatening the safety of other people present at the event. If the Participant would notice the fire or other hazardous situation, the Participant should as soon as possible report it to Organizer or service of the building.
- 6.3 The Organizer reserves the right to earlier end of the Conference, if there is possibility that health and life of Participants is at risk.
- 6.4 It is forbidden to barricade the evacuation escapes, emergency routes, access routes for rescue service or fireplugs and other equipment necessary in the case of the rescue or firefighting action during the event.
- 6.5 It is forbidden to destroy signs, indicators, advertising mediums, equipment and devices in the area of the Wrocław University of Science and Technology.

§7

Final Regulations

- 7.1 The Participant is responsible for all inflicted damages and is obliged to take material and legal responsibility for them. In case of damages occurrence the Organizer prepares the protocol from incident, in which causer is obligated to cover the cost of damages. If the damages would be made intentionally, after preparation of the protocol the Participant would be expelled immediately from the Conference.
- 7.2 Infringement of the Regulation by the Participant or violation of public order is authorizing the Organizer to expel the Participant from the event.
- 7.3 In accordance with the Act on the Protection of Personal Data of 29 August 1997 (Dz.U.133 z dnia 29 października 1997 r., poz. 833.) the Organizer of the Conference does not transfer, sell and lend collected personal data of Participants to other persons or institutions. Personal data provided by the Participant is treated as confidential information and is used only for communication purposes between the Participant and the Conference Organizer.
- 7.4 The Organizer is not responsible for the items of Participants that may be lost, damaged or stolen during the Conference.
- 7.5 Participation in the Conference means giving permission to the recording, photographing, filming or other recording of the Participant's image and to broadcast, distribute or display this image and voice in connection with the promotional and information activities conducted by the Organizers. The organizer also reserves the right to provide, with the consent of the Participants, e-mail addresses to the sponsoring company, with which the Organizer cooperates in order to conduct a survey and other promotional campaigns. The participant is not entitled to any claims against the Organizer due to the above-mentioned activities.
- 7.6 The Organizer will publish an abstract book in electronic form, which will be available on the Conference website up to one month after the Conference.
- 7.7 In any case not regulated by hereby Regulations, the Polish law should be applied.
